- Contribute to the development and dissemination of communication and knowledge products of the strategy in coordination with the governance team based at the ECOWAS Vice President's Office;
- Ensure the coherence and quality of data from stakeholders and data contained in the various governance platforms of the Strategy in coordination with the HCD technical team based in the office of the Vice President.

The candidate must have skills in software development, database and networks, etc.
